

Camp Conquest Camper COVID-19 Waiver 2021

- 1. I acknowledge that Camp Conquest is taking reasonable precautions to mitigate the risks associated with COVID-19. I understand that such risks cannot be eliminated entirely, as COVID-19 may spread through multiple pathways. I also understand that although reasonable precautions are taken, my child may become infected with COVID-19. I also understand the health risks associated with COVID-19 include infection, including potential exposure to others, including family members.
- 2. I expressly agree to accept and assume all risks associated with COVID-19 related to my child's participation in the Program. I have elected to allow my child to participate in the Program despite the risks of being exposed to and/or contracting COVID-19. I recognize that this decision is purely voluntary and that I have the right to discontinue my child's participation in the Program at any time.
- 3. I understand that Camp Conquest may modify and/or cancel a Program as a result of COVID-19 issues or may be directed to modify and/or cancel a Program by government authorities.
- 4. I understand that Camp Conquest reserves the right to isolate, remove, quarantine, and/or dismiss my child for reasons related to or arising from COVID-19 and agree and consent that Camp Conquest maytake all reasonable steps to maintain and protect the health and welfare of my child, other Campers, Staff, and Volunteers.
- 5. I acknowledge that I may elect to receive and Camp Conquest will provide a registration refund should I cancel my child's participation in the Program for COVID-19 reasons prior to the start date of the camp term for which he/she is registered. I understand prorated registration refunds will be considered if your child's participation is discontinued after the camp term start date but before the end of the camp term. I will remain solely responsible for my other costs incurred in connection with my child's participation in the Program, including transportation, lodging, health care and incidental costs, even in the event that Camp Conquest is required to or deems it necessary to cancel or modify the Program, or Camp Conquest dismisses my child from the Program.
- 6. I represent to Camp Conquest or will represent to Camp Conquest prior to presenting my child for participation in the Program that, to my knowledge, my child (a) has not been exposed to a person presumed or confirmed to have COVID-19 within the fourteen days preceding my child's participation in the Program, and (b) is free of any signs and symptoms of COVID-19 (which may include a fever, a dry cough, excessive fatigue, shortness of breath, loss of taste, loss of smell). I represent I will promptly notify Camp Conquest of any change in my child's medical status that occurs prior to the start date of the camp term for which he/she is registered and of a positive COVID-19 test result for any person in my child's and/or my immediate household after my child arrives at Camp Conquest.

- 7. I hereby voluntarily release, waive, indemnify, and hold harmless, and forever discharge any and all claims against Camp Conquest, its board of directors, officers, employees, volunteers, agents, and all other persons or entities affiliated with Camp Conquest or acting on its behalf that relates in any way to COVID-19, including but not limited to any liabilities, claims, negligence, suits, and settlements, or otherwise, arising from or relating to my child's exposure to, infection with, or other harm related to COVID-19 while participating in the Program and/or following participation in the Program, and also including harm related to my child's spread of COVID-19 to me and/or others including family members, losses, fines, judgments, settlement, and expenses (including reasonable attorney fees) which may be incurred by Camp Conquest as a consequence of my child's exposure to COVID-19, resulting in the illness or infection of my child or of a third party.
- 8. The provisions of this Addendum are severable, and if any provision of this Addendum is held to be invalid or unenforceable, the remaining provisions will remain in full force and effect.
- 9. This Addendum is intended to supplement the Parent Release, and Terms and Conditions previously executed and is in addition to the terms stated therein, which shall remain in full force and effect. By signing this Addendum, which includes an assumption of risk, release, waiver of liability, and indemnification agreement related to COVID-19, I expressly state that I have had sufficient opportunity to read it in its entirety. I further certify that I have read and understood it, and I agree to be bound by its terms.
